Policy for Taking Parental Approval for Building Family Trees on MyOrigins.ai

1. Objective

The purpose of this policy is to ensure that minors (individuals under the age of 18) seeking to create or contribute to a family tree on MyOrigins.ai obtain explicit approval from their parents or legal guardians. 2. Scope
